

Delaware County Libraries Board of Directors MINUTES Thursday, October 19, 2023 6:30 p.m.

a. Library Services Director position (K. Suda)

The Library Services Director position has become vacant, effective October 13th. The job description and requisition have been forwarded to the County's Human Resources for review and posting and is anticipated the position will be posted in the next few weeks.

b. Countywide In-Service November 3, 2023 (A. Laepple)

198 staff representing 25 libraries have registered to participate in the County-Wide In Service on Friday, November 3. Attendees will earn 6 hours of continuing education credit, helping to fulfill the State Aid standard requirement.

6. Administrator's Report

a. Member Library Audits/Reviews (A. Laepple)

Audits/financial reviews must be submitted to DCL as soon as possible and prior to the distribution of State Aid the following year. Audits/financial reviews will be submitted to OCL as part of the SALSA (State Aid Library Subsidy Application) process. Trustees were encourage to ensure that the library's audit or financial review is submitted to the District Consultant as soon as it is completed.

b. 2023 State Aid Disbursement (A. Laepple)

Review of last year's action in relation to the Borough of Folcroft Public Library and State Aid: due to inability to provide an audit or financial review for 2019 and 2020, the DCLB, acting on the recommendation of the Pennsylvania Department of Education Office of Commonwealth Libraries withheld State Aid and redistributed it to the remaining eligible libraries.

The Borough of Folcroft Public Library additionally missed the October 1, 2022, deadline to submit a 2021 audit, and indicated on the State Aid Library Subsidy Application (SALSA) submitted in September 2023 that said audit would not be possible, thus forfeiting the 2023 State Aid distribution.

DCL recommended that the \$28,107 of forfeited State Aid to Libraries funds be equally distributed to the remaining eligible member libraries.
